

## of a 13.00 Acre Tract Nancy Anderson League, A-72 Grimes County, Texas May 12, 2016

All that certain tract or parcel of land lying and being situated in Grimes County, Texas, out of the Nancy Anderson League, Abstract No. 72, being a part of a called 34.411 acre tract as described in a General Warranty Deed with Vendor's Lien from Brent Dean Wornat, et al to Robert H. Lang, Jr., dated March 3, 2016, of record in Volume 1589, Page 677 of the Real Property Records of Grimes County, Texas and more fully described as follows:

**COMMENCING** at the Westerly or Southwest corner of the called 34.411 acre tract mentioned above, the Southerly corner of a called 9.0 acre tract as described in a Deed to Gary L. Slaton, et ux (1273/680) and same being in the Northeast ROW line of State Highway 39 as described in a Deed to the State of Texas (149/277);

THENCE S 46°32'23" E, 1,009.56 ft., along the fenced and Northeast ROW line of State Highway 39 and the Southwest line of the called 34.411 acre tract mentioned above to a set 1/2 inch iron rod for the Westerly corner and the **TRUE PLACE OF BEGINNING** of the tract of land herein described;

THENCE N 43°56'33" E, 746.69 ft., crossing over the called 34.411 acre tract mentioned above and along the Northwest line of the tract of land herein described to a set 1/2 inch iron rod, 15.0 ft. Southwest of a barbed wire fence line, for its Northerly corner in a Northeast line of said 34.411 acre tract and in the Southwest ROW of the Chicago Rock Island Railroad, from which a found 1/2 inch iron rod for an angle in said ROW brs. N 43°16'51" W, 472.22 ft.,;

THENCE along a common line of the called 34.411 acre tract mentioned above and said Railroad ROW as follows:

- 1) S 43°16'51" E, 427.78 ft., to a found 3/8 inch iron rod (bent) 12.2 ft. Southwest of said barbed wire fence line,
- 2) \$ 46°43'09" W, 25.00 ft., to a found 3/8 inch iron rod at the base of a 1 inch by 36" iron pipe;
- 3) \$ 43°16'51" E, 366.21 ft., to a found 1/2 inch iron rod, 1.5 ft. Northwest of a new barbed wire fence line and 29.4 ft. Southwest from a 3 inch iron pipe fence corner post, for the Northwest corner of a 1.000 acre tract out of said 34.411 acre tract as described in a Deed to Janice Bennett (1583/622);

THENCE S 43°26'33" W, 676.57 ft., along the fenced and Northwest line of said 1.000 acre Bennett tract (1583/622) to a set 1/2 inch iron rod, near the base of a new 3 inch iron pipe fence corner post, for its Westerly corner, the Southerly corner of the tract of land herein described, in the Southwest line of the

called 34.411 acre tract mentioned above and same being in the Northeast ROW line of State Highway 39, from which a found concrete ROW monument brs. S 46°32'33" E, 1,749.21 ft.;

THENCE N 46°32'23" W, 797.78 ft., along the fenced and Northeast ROW line of State Highway 39 and the Southwest line of the called 34.411 acre tract mentioned above to the **TRUE PLACE OF BEGINNING** and containing 13.00 acres of land.
