AND THE NORTHEAST CORNER OF THE HEREIN DESCRIBEDTRACT;

THENCE: S 31 28'18'' W, ALONG A WEST LINE OF SAID SH 105 R.O.W. FOR A DISTANCE OF **61.56 FEET** TO A CONCRETE MARKER FOUND ON THE NORTH R.O.W. LINE OF COUNTY ROAD 217, MARKING THE MOST SOUTHERLY SOUTHWEST CORNER OF SAID 3.15 ACRE STATE TRACT, AND THE SOUTHEAST CORNER OF THE HEREIN DESCRIBED TRACT;
