Commencing at a ¾ inch pinched top pipe found at a fence corner at the southeast corner of said 172.19 acre tract, located at the northeast corner of a called 6.04 acre tract to Staci Carla Danford Rotello, (1322/260), also located on the west line of Whipporwill Estates, Phase 1, (808/232);

Thence along the south line of said 172.19 acre tract, with the north line of said 6.04 acre tract S 86°31'54" W a distance of 902.78 feet to a calculated point at the northwest corner of said 6.04 acre tract, located at the upper northeast corner of a called 22 acre tract to Kent A. Taylor, et al, (District Court Cause No. 26061, & 690/466 D.R.);

Thence continuing along said south line, with the north line of said 22 acre tract and generally along an old fence line S 86°18'19" W a distance of 580.58 feet to calculated point at the northwest corner of said 22 acre tract, located at the northeast corner of a called 379.30 acre tract to Magnolia Hill Ranch LTD, (1366/717), from which a 5/8 inch iron rod found (disturbed) bears N 61°04'14" E a distance of 0.80 feet;

Thence continuing along said south line, with the north line of said 379.30 acre tract and generally along said old fence line S 86°25'44" W a distance of 227.10 feet to a 1/2 inch iron rod with yellow cap set for the southeast corner and **POINT OF BEGINNING** of this;
